In accordance with the indications formulated in ISO, which do not allow the issuance of certifications referring to guidelines, SGS, within the framework of the ISO20400:2017 guidelines, carries out a verification activity resulting in the issuance of an assurance statement independently veryfing the adoption of the ISO20400:2017 guidelines by the Organization as a reference model for sustainability and sustainable procurement initiatives.

The "SGS ISO20400 Gap Analysis Tool v.2.0" was the tool used for this analysis. This approach, designed in line with the structure of the ISO20400:2017 guidelines, involves an assessment of sustainable procurement requirements according to 4 basic macro-areas, which form the very structure of the guideline: "Fundamentals, Policy & Strategy, Organizing the Procurement Function, Procurement Process."

Developed in consistency with other SGS approaches aimed at assessing the maturity of sustainability management models (e.g., ISO 26000:2010 - Guidance on social responsibility), the tool enables assessment of the key requirements of the ISO20400:2017 guidelines.

The verification team was chosen based on each member's technical expertise, experience, and qualification about the different aspects assessed.

The verification activities were carried out in September 2023, involving different functions of the Organization.

This Assurance Letter does not refer to a specific period of validity but refers to what was assessed during the verification.

CONCLUSIONS
